

### Welcome to Brushy Creek Municipal Utility District



### BCMUD is a MUD, what is a MUD?

A Municipal Utility District (MUD) is a type of local governmental entity. Other examples of local governmental entities are a county, city, school district, junior college, drainage and flood-control districts.

A MUD is governed by a 5-person Board of Directors that is elected by the residents within the MUD. The Board's primary functions are to oversee the MUD's management, affairs, and operations, establish policies, adopt tax rates, and establish water, sewer, solid waste, and recreational fees and charges.


The taxes of the MUD are levied and collected to finance the costs of public infrastructure improvements that serve residents of the District, and to fund maintenance and operation costs that are not funded by retail rates and charges.



#### **BCMUD's primary functions:**

- Own and operate a Public Water Supply (PWS) system that treats and distributes drinking water to residents
- Own and operate a wastewater collection system to provide sewer service to District residents
- Own and operate a Managed Separate Storm Sewer System (MS4) drainage and stormwater facilities
- Own and operate parks and recreational facilities, including programs for District residents
- Provide street lighting and trash/recycling services


### **BCMUD ABOUT US**



- Established in 1977, at 46 years old is home to over 21,000 residents over 4 square miles.
- Utilities: Water intake facility supplying an 11-mile raw water line, a Superior-rated water treatment/delivery system (60 miles), wastewater conveyance (60 miles), and a Municipal Separate Storm Sewer System (MS4).
- Parks and Recreation: Over 300 acres of parkland with 11 parks, 8 playgrounds, 6 miles of trails, 5 pavilions, 5 basketball courts, 4 pools, a splash pad, 3 tennis courts, 3 volleyball courts, a 65,000 sq ft community center, a Community Garden, greenbelts, 32 Karst Caves, an 18-hole disc golf course, leagues, camps, and extensive programming.
- Customer Service: Street lighting, Trash and Recycling service
- Employees: Over 60 full-time, Over 80 part-time, and over 90 seasonal
- BCMUD does NOT: manage Roads/Sidewalks, nor provide Fire Protection, Law enforcement, and Electric power


#### BULK PICK-UPS MARTY KOOPMAN, CUSTOMER SERVICE SUPERVISOR

### **Bulk Pick-Ups**

- Residents get 2 annual curbside bulk item or brush pick up services per year
- Bulk pickups are scheduled for Saturdays
- 3 cubic yards = 1 bulk pickup

### **Unacceptable Items**

- Any hazardous items, chemical compounds, mixtures, or substances
- Motor oil, gasoline, or tires
- Items considered to be construction, demolition material/ debris, or paint

- Paint/ Thinner
- Home Chemicals
- Batteries
- Automotive Fluids
- Motor Oil/ Oil Filters
- Antifreeze
- Cleaners
- Aerosol Cans
- Stain/ Lacquer
- Pool Chemicals
- Herbicides/ Pesticides
- Fertilizer



- No more than 25 one-gallon cans
- No containers larger than 5
  gallons
- No business/ contractor waste
- No ammunition, explosives or shock sensitive materials
- No smoke detectors or other radioactive materials
- No needles, sharps, or other bio-medical wastes
- No tires


